Description

This document describes the data included in the 'Further education and skills: November 2021' National Statistics release's underlying data files. This data is released under the terms of the <u>Open Government License</u>. It is provided to allow users to interrogate the data themselves.

The underlying data files cover England and include Further Education and Skills learner participation/achievements, and aim enrolment/achievement figures. Some tables also include further breakdowns; by provision type (e.g. education and training, community learning, or apprenticeships), by learner characteristics (e.g. age, gender, ethnicity group) or subject characteristics (e.g. sector subject area, level, learning aim).
