Metadata specification

Description

This document describes the data included in the 'Apprenticeships and traineeships: November 2022' National Statistics release's underlying data files. This data is released under the terms of the Open Government License. It is provided to allow users to interrogate the data themselves.

The underlying data files contain apprenticeship starts, achievements and participation figures in England; broken down by learner characteristics (e.g. age, sex, ethnicity group), geography (e.g. region, local authority district) and subject characteristics (e.g. sector subject area, level, framework/standard name).

The <u>Further education and skills statistics: methodology</u> document published alongside the main release should be referenced alongside this data. It provides information on the data sources, their coverage and quality as well as explaining methodology used in producing the data.

This dataset comprises content supplied by recruiters and published by the ESFA, as advertisements for Apprenticeship vacancies in England, on the digital service Find An Apprenticeship.

The service is operated by DfE as a recruitment platform, free at point of use. It enables:

- Employers to publicise Apprenticeship vacancies;
- Candidates to apply for vacancies, and;
- Recruiters to manage the recruitment process for the vacancies displayed on the service.

A Vacancy is defined as a single opportunity for a unique individual to be employed as an Apprentice. A single advertisement (previously referred to as a Vacancy Notice) may contain one or more Vacancies.

The dataset comprises the items listed below. All standard fields are populated using a standardised selection of data items, some are automatically system-populated. The content of free text fields is drafted by the author of an advertisement and is not restricted by the system. Please note that any apprenticeships arising as a result of the vacancy must comply with ESFA apprenticeship funding rules.

SourceDb (Standard field)

Identifier for the database through which the advertisement is processed. Version 1 (V1) is a legacy system, used predominantly by training providers, recruiting on behalf of employers. Version 2 (V2) is used predominantly by employers accessing the system through their digital accounts with the Apprenticeship Service (AS).

Trainingtype (Standard field)

Identifies whether vacancy learning element is based on apprenticeship standard or framework.

VacancyDescription (Free Text field)

A summary of the apprenticeship content and working environment.

VacancyPostcode (Standard field)

The postcode of the workplace location where the apprenticeship is based.

VacancyReferenceNumber (Standard field)

System Alphanumerical 12-digit UID for each advertisement.

VacancyTitle (Free Text field)

The employer's chosen descriptor for the vacancy/vacancies advertised.

Annex B – Notes for interpreting the underlying data for the public sector target return

- 1. Sub sector is allocated based on a mapping of Apprenticeship Service account (ASA) names to public sector bodies.
- 2. Staff in schools maintained by a Local Authority are included within the figures for the Local Authority.
- 3. State-funded schools not maintained by a Local Authority (e.g. academies and academy trusts) are in scope for the target from 2018-19 and are included in the 'Schools' sub-sector. A small number of academy trusts made a return in 2017-18 and have been included in the 'Other' sub-sector category for 2017-18.
- 4. New apprentices includes employees who were already working for the body before beginning their apprenticeship, as well as new apprentice hires.
- 5. Several bodies have not been included in national and sub-sector average. Possible reasons for exclusion are listed below: i) they had fewer than 250 employees at the start of the reporting period and are therefore out of scope for the target in that period ii) they are part of the Civil Service and have already been included as part of the wider Cabinet Office return for the whole Civil Service (to avoid double counting). iii) they have not been identified as a public sector body through internal mapping of Apprenticeship Service Accounts. iv) the total number of apprentices declared at the start or end of the reporting period is greater than or equal to the overall reported headcount for the same period.
- 6. Only figures that have been included in national and sub-sector averages during the initial 4-year target period have been used in 'cumulative' calculations. Organisations with no results included in national aggregates in any year will show as "z" for 'cumulative' fields. All cumulative fields for the 2021-22 reporting period will show as "z" as not applicable to the original 4-year target. Where an organisation sent only a partial return, "w" has been used to show fields not completed.
